APPROVING SUPPLEMENTAL AGREEMENTS TO THE SOUTHEAST CONNECTOR PROFESSIONAL SERVICES AGREEMENT WITH KIRKHAM MICHAEL & ASSOCIATES TO PROVIDE ADDITIONAL CONSTRUCTION PHASE SERVICES FOR THE SOUTHEAST CONNECTOR PROJECTS

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That Supplemental Agreements No. 6 and 7 to the Professional Services Agreement between the City of Des Moines and Kirkham Michael & Associates, Inc., Roger Helgoth, P.E., President, 12700 West Dodge Road, Omaha, NE, to provide additional construction phase services for the Southeast Connector construction projects, for a cost plus fixed fee not to exceed \$419,160, copies of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That, subject to final Iowa Department of Transportation approval, the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Professional Services Agreements for and on behalf of the City of Des Moines, Iowa.
