BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Chief Civil Engineer, showing the cost of construction of the M. L. King Jr. Pkwy Paving SW Second Street to SW Seventh Street, Activity ID 06-2000-004, Project No. NHSX-U-2787(304)-8S-77 and STP-E-2787(305)-8V-77, in accordance with the contract approved between M. Peterson Construction Co., Merlin Peterson, President, 4000 Delaware Avenue, Des Moines, IA, 50313, under Roll Call No. 00-3243, of July 24, 2000, and the City of Des Moines, Iowa, and recommending the acceptance thereof, be and the same is hereby approved, and accepted, and

BE IT FURTHER RESOLVED: That \$5,699,467.87 is the total cost, of which \$5,668,099.85 has been paid the Contractor, and \$1,368.02 is now due and is hereby approved as final partial payment for the above project, the remaining balance of \$30,000.00 is to be paid at the end of thirty days, provided no claims or liens have been filed against said contract. In the event that at the end of said thirty (30) day period, claims are on file as herein provided, the City shall continue to retain from said unpaid funds, a sum not less than double the total amount of all claims on file, or the full 5%, Chapter 573, Code of Iowa retainage amount, whichever is lesser.

BE IT FURTHER RESOLVED: That the Engineering Department be and is hereby authorized and directed to notify all persons and firms with outstanding Chapter 573 claims against said project, that the project has been given final acceptance as completed by this City Council, that they have 60 days from such acceptance within which to initiate suit to collect on their claims, and that if suit is not commenced within that time, the City will be required to release the retainage which it is now holding.

BE IT FURTHER RESOLVED: That the Finance Department be and is hereby authorized to release said retainage if suit is not filed as above provided.

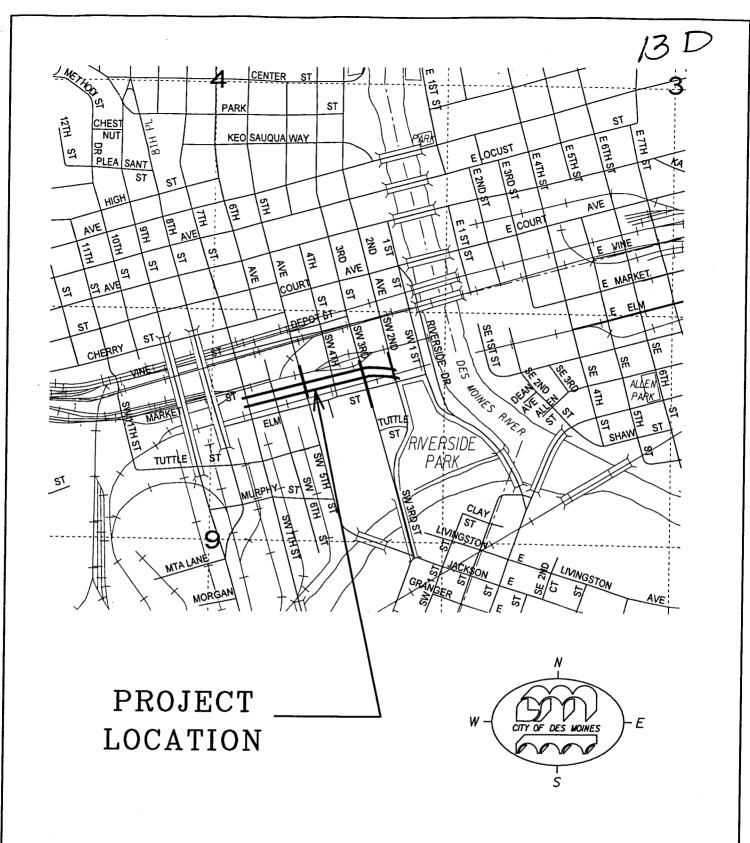

On July 24, 2000, under Roll Call 00-3243, the City Council awarded the contract for the above improvement to M. Peterson Construction Co. in the amount of \$5,586,729.32. This project consist of Portland Cement Concrete Pavement 260 MM (10 inches) thick, with various width pavement and median; together with the necessary sidewalk, driveway, storm sewer, traffic signals, street lighting, water main construction, intersection enhancements, landscaping including an irrigation system, and construction survey; all in accordance with the contract documents including Plan File Nos. 382-001/252, on Martin Luther King Jr. Parkway from SW 2nd Street to SW 7th Street.
