## RESOLUTION ESTABLISHING FAIR MARKET VALUE AND AUTHORIZING ACQUISITION OF PROPERTY FROM GRAND VIEW COLLEGE LOCATED AT 2600 EAST 14<sup>TH</sup> STREET FOR THE EAST 14TH STREET WIDENING - ARTHUR AVENUE TO EAST TIFFIN AVENUE PROJECT

**WHEREAS,** on September 12, 2005, by Roll Call No. 05-2167, the City Council approved and authorized the execution of Iowa Department of Transportation pre-design agreement for E. 14<sup>th</sup> Street (U.S. 69) from E. WHEREAS, the right-of-way requirements have been determined and the following property has been appraised by an independent appraisal firm, and the appraisal was reviewed by the Iowa Department of Transportation (IDOT); and,

WHEREAS, based upon the appraisal, the suggested fair market value of the property is as follows:

Property Interests to be Acquired: Partial Fee Simple & Temporary Easement for Construction

Suggested Fair Market Value: \$37,700.00


