WHEREAS, the City has received an application from Midland Boesen LLC, represented by Jerry Matalone, for a sidewalk café to be used in conjunction with the business operation of Amici Espresso on a portion of the sidewalk adjoining the Midland Building at 206 6th Avenue; and,

WHEREAS, the right-of-way adjoining the Midland Building at 206 6th Avenue has not been previously vacated; and,

WHEREAS, the affected portion of the public right of way must first be vacated before the City may approve the proposed Sidewalk Café Lease; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating a portion of the 6^{th} Street and the Mulberry Street right-of-way adjoining the Midland Building at 206 6^{th} Avenue, more specifically described as follows:

A portion of the Mulberry Street right of way lying south of and adjacent to Lot 5, Block 11, Fort Des Moines, an Official Plat, Des Moines, Polk County, Iowa, all more particularly described as follows: Commencing at the southeast corner of said Lot 5; thence South 74°(degrees) 14'(minutes) 03"(seconds) West along the south line of said Lot 5 said line being the north right of way line of said Mulberry Street as it is presently established, a distance of 15.50 feet to the point of beginning; thence South 15°45'57" East, a distance of 4.25 feet; thence South 74°14'03" West, a distance of 45.00 feet; thence North 15°45'57" West, a distance of 4.25 feet to the south line of said Lot 5; thence North 74°14'03" East along the south line of said Lot 5, a distance of 45.00 feet to the point of beginning (containing 191.25 square feet more or less); and,

A portion of the 6th avenue right of way lying east of and adjacent to Lot 5, Block 11, Fort Des Moines, an Official Plat, Des Moines, Polk County, Iowa, all more particularly described as follows: Commencing at the southeast corner of said Lot 5; thence North 15°(degrees) 30'(minutes) 00"(seconds) West along the east line of said Lot 5 said line being the west right of way line of said 6th Avenue as it is presently established, a distance of 19.00 feet to the point of beginning; thence continuing North 15°30'00" West along the east line of said Lot 5, a distance of 38.00 feet; thence North 74°30'00" East, a distance of 4.11 feet; thence South 15°30'00" East, a distance of 38.00 feet; thence South 74°30'00" West, a distance of 4.11 feet to the point of beginning (containing 156.18 square feet more or less).
