- 2. **Liability:** The State of Iowa shall not be responsible for damages to property or injuries to persons which may arise from, or be incident to, the use of Camp Dodge grounds and facilities. The State of Iowa shall not be responsible for any claim, regardless of kind, related to activities undertaken pursuant to this lease. The lease shall indemnify and hold harmless the State of Iowa from any and all claims, damages, expenses and liabilities arising out of its use of Camp Dodge's grounds and facilities.
- 3. **Permits and Licenses: The** lessee shall obtain all permits and licenses required for its activities at Camp Dodge. The State of Iowa shall not be responsible for the lessee's failure to obtain such permits and licenses or to comply with any other requirements imposed upon the lessee for the conduct of its activities.
- 4. **Compliance With Laws: The** lessee shall comply with all applicable laws, ordinances, rules and regulations. The State of Iowa shall not be responsible for the lessee's failure to comply.
- 5. **Insurance:** The lessee shall obtain adequate insurance coverage for persons and property associated with activities conducted pursuant to this lease.
- 6. **Internal Security: The** lessee shall be responsible for internal security of personnel and property within the areas assigned to it. The lessee accepts full responsibility for the conduct of all persons admitted to Camp Dodge pursuant to this lease.
