AN ORDINANCE vacating Watson Powell Jr. Way between 2nd Avenue and Grand Avenue.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and


Sec. 4. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
