WHEREAS, on May 4, 2007 the City of Des Moines, Iowa terminated the District 2 eastside impounded vehicle towing and storage services contract with American Towing due to non-compliance with contract specifications; and

WHEREAS, the Police Department requested the Procurement Division to solicit bids for a replacement agreement for District 2; and

WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid V07-118 to sixteen (16) potential bidders with eight (8) bids received; and

WHEREAS, the low dollar compliant bid was received from Crow Tow, 208 3rd Street, Altoona, IA 50009; and

WHEREAS, the Procurement Administrator and the Police Department recommends approval of the low dollar compliant bid;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the low compliant bid for impounded vehicle towing and storage services for District 2 to Crow Tow, and further authorizes the Procurement Administrator to enter into an annual agreement expiring on May 31, 2008, and renewable for one (1) additional twelve (12) month period.
