APPROVING PROPOSAL FOR THE PROVISION OF REGIONAL GEOGRAPHIC INFORMATION SYSTEM PLANIMETRIC UPDATE AND MAINTENANCE IMPLEMENTATION PLAN AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A CONTRACT FOR THE PROVISION OF SAME

WHEREAS, by Roll Call No. 03-2313 on October 6, 2003 the City Council authorized the City Manager to submit an application for federal funds to develop the Des Moines Regional Geographic Information System (GIS) to enhance homeland defense and emergency capabilities; and

WHEREAS, pursuant to such grant application, the City of Des Moines was awarded a \$384,900.00 FY2003 Bureau of Justice Assistance Congressionally Mandated Awards Byrne Discretionary Grant for such GIS Planimetric update mapping and maintenance implementation plan services for Polk County and portions of Dallas, Warren, Madison, Boone and Story Counties; and

WHEREAS, on February 16, 2006, the Procurement Division issued a Request for Proposals (VO6- 095) for such GIS Planimetric update mapping services and maintenance implementation plan services and 3 proposals were received; and

WHEREAS, the evaluation and selection committee reviewed the proposals and have recommended that a contract for the provision of such services be awarded to Sanborn Map Co., Colorado Springs, Colorado, in an amount not to exceed \$384,900.00.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the proposal submitted by Sanborn Map Co., is hereby accepted.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to negotiate and execute a contract with Sanborn Map Co., for the provision of the above described services in an amount not to exceed \$384, 900.00, subject to review and approval as to form by the Legal Department.
