APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR ALLEY PAVING IMPROVEMENTS, ALLEY STARTING AT DES MOINES STREET AND RUNNING APPROXIMATELY 150 FEET TO THE NORTH, AND IS LOCATED ONE BLOCK TO THE WEST OF 600 EAST 30^{TH} STREET

BETWEEN BREIHOLZ CONSTRUCTION COMPANY AND GREATER IOWA CREDIT UNION

WHEREAS, on October 20, 2003, under Roll Call No. 03-3272, the City Council approved a private construction contract in the amount of \$6,250.00, between Breiholz Construction Company, David J. Ward, President, 202 Des Moines Street, Des Moines, IA - as Contractor, and Greater Iowa Credit Union, Merrill Kay Sharp, President, 801 Lincoln Way, Ames, Iowa - as Owner, for construction of Alley Paving Improvements described as paving a section of alley starting at Des Moines Street and running approximately 150 feet to the north and is located one block to the west of The Greater Iowa Credit Union at 600 East 30th Street as per Plan File No. 423 – 011, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Chief Civil Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Chief Civil Engineer acknowledging the completion and recommending the acceptance of the construction of said Alley Paving Improvements in the amount of \$6,250.00, which have been constructed in substantial compliance with the contract documents between Breiholz Construction Company and Greater Iowa Credit Union, which were approved under Roll Call No. 03-3272, dated October 30, 2003, be received and filed; and that completion of said Alley Paving Improvements described as paving a section of alley starting at Des Moines Street and running approximately 150 feet to the north and is located one block to the west of The Greater Iowa Credit Union at 600 East 30th Street, Des Moines, Iowa, as per Plan File No. 423 – 011, is hereby acknowledged and that said Alley Paving Improvements are hereby accepted.


