APPROVAL OF TRANSFERRING \$50,000 OF FUNDING FROM THE UNITED WAY OF CENTRAL IOWA TO THE POLK COUNTY HOUSING TRUST FUND TO FUND THE POLK COUNTY HOUSING CONTINUUM COORDINATOR

WHEREAS, on November 19, 2007, by Roll Call No. 07-2231, the City Council of the City of Des Moines approved the Proposed Fourth (2008) Year Action Plan of the 2005-2009 U.S. Department of Housing and Urban Development (HUD) Consolidated Plan, which Plan included allocation of Community Development Block Grant (CDBG) funding for the development of an integrated supportive housing system; and

WHEREAS, the aforesaid CDBG allocation has been utilized to pay for a consulting contract with Technical Assistance Collaborative, Inc., for development of an Action Plan addressing the housing system; and

WHEREAS, on June 23, 2008, by Roll Call 08-1111, the City Council approved an Investment Agreement with United Way of Central Iowa to co-fund the housing consultant in the amount of \$50,000 for development of the Action Plan addressing the housing system; and

WHEREAS, the Polk County Housing Continuum Coordinator is serving as the homeless assistance coordinator to implement the Action Plan being developed by Technical Assistance Collaborative, Inc. to address the needs of the homeless population; and

WHEREAS, the City and United Way of Central Iowa agree that the funding provided by the Investment Agreement is necessary at this time to fund the Polk County Housing Continuum Coordinator position at the Polk County Housing Trust Fund (Attachment).

NOW, THEREFORE, BE IT RESOLVED by the City of Des Moines City Council that the \$50,000 of funding provided by the Investment Agreement with the United Way of Central Iowa, be transferred to the Polk County Housing Trust Fund.


