WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid V09-141 to six (6) potential bidders with two (2) bids received; and

WHEREAS, the low dollar compliant bid was received from Charles Gabus Ford, 4545 Merle Hay Road, Des Moines, IA 50310, Gene Gabus, President, at a total cost of \$527,165.10; and

WHEREAS, patrol cars are available from Ed Stivers Ford, 1450 E. Highway 6, Waukee, IA 50263, Don Politte, President, per State of Iowa Contract 3449-09, at a total cost of \$494,714.00; and

WHEREAS, Municipal Code section 2-726© provides for the purchase of goods and/or services from contracts established by the State of Iowa Department of General Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Code of Iowa and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, funding in the amount of \$269,844.00 is available from CMO010407/Equipment Replacement, and funding in the amount of \$224,870.00 is available from POL984135/Justice Assistance Grant (JAG); and

WHEREAS, the Procurement Administrator and the Fleet Maintenance Manager recommends approval of using the state contract award;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to Ed Stivers Ford for 22 patrol cars at a total cost of \$494,714.00.
