Memo

At Issue: Proposed 515Alive Event Street Closure in East Village

To: City Council, Mayor and City Manager

From: Marsha Steele, Business Owner at 520 East Grand Ave & President, Historic East Village Board

Promoters for the 515Alive event want to move the event from Court Avenue (held there the past 7 years) to the East Village. They presented a petition to the Street Closure Committee with 18 responders. 6 disagreed with the event and 4 more subsequently changed their votes to also disagreed, resulting in 55% declining to support the event. The petition itself is incomplete/ fraudulent because it fails to "contain all names of the business owners / residents of the abutting area". The promoters submitted an application for street closure of the disputed 500 block of East Grand in mid-June, however they sent out press releases on May 15th stating it would be held on this block. Business owners on this block do not support the event by an 87.5% margin. The city has proposed alternate streets as have I; my recommendation is closure of the 400 block of East Grand. The Street Closure Committed chose to send this issue to the City Council for resolution. On behalf of the business owners on the 400 block of East Grand, I request the city rule the event take place on the 400 block of East Grand (and the undisputed 400 block of East 5th Street).

1st Attachment - the April 2009 description of the event including art show, automobile show, food donations to pantries / shelters, etc, all of which presents a culturally diverse mix of activities.

While on Court Avenue, the event impacted only bars and restaurants. However if held on the 500 block of Grand it would impact 14 retail / service businesses plus 2 bars/restaurants. In April the Street Closure Committee recommended alternate sites within the East Village to Mr. McCabe, because of business owners' concerns. He verbally committed they would not hold the event on retail blocks; they would find another street adjacent to the 400 block of East 4th (which contains 4 bars, some of whom are event sponsors).

On 4/24/09 I met with the promoters to discuss concerns about holding the event on a block with retail/service businesses. I asked Mr. Parmerlee why they wanted to move the event after 7 years on Court Avenue. He said the event is a "drunk fest" (exact quote) and they hoped by moving it to the 'culturally diverse East Village & getting different sponsors", it would not be a drunk fest.

2nd Attachment - the promoters' May 15th press release email to prior attendees and fans stating the event <u>will be held</u> on the 500 block of East Grand (this is a month before they made application for street closure – and approval has not yet been granted). This email presents a different description of the event, talking mostly about the music, a car "they're gonna let you smash" and "most importantly "we got lots and lots and lots and lots of discounted booze and beer". Based on this press release and the very different focus of the event, I contacted the 16 retail / service businesses on the 500 block of E Grand to petition them about the event.

3rd Attachment - the promoter's petition – Of the 18 listed businesses, the Grand Piano Bistro, Dornink, Olympic Flame and New Oriental Food Store checked they were <u>not</u> in favor of the event. Note that 2 (eden and American Plumbing) changed their 'approval' vote to <u>no</u>, emailing their comments to the city because the actual event was something different than originally described. Note also Mr. Parmerlee certifies that the petition "contains all names of the business owners / residents of abutting area". In fact 4 business owners on the 500 block of E Grand are not listed on the petition including FoundThings, Jim Boyt, Tim Rypma, and Jody Goode, CPA (all of whom voted not in favor of the event).

4th Attachment - the East Village petition of 6/8/09 listing all businesses on the 500 block of East Grand, with 14 of 16 not in favor of holding the event on our block. Note that 4 business owners changed their minds on this petition and voted <u>no</u> to the event being held on our block (Miyabi 9, William A Van Orsdel, Dunbar/ Jones and JP-SE). I interviewed each person and provided a copy of the promoters' May 15th email press release. The 2 businesses in favor of the event are House of Bricks and Artisan's Jewelry.

Final comments:

As the new President of the Historic East Village board, I want to say the East Village is first and always a neighborhood. We're made up of over 300 residences, property owners (developers) and retail and service businesses including bars and restaurants. Our Mission Statement is: To lead the preservation, support and development of the East Village <u>Community</u>."

Secondly, all events are not created equally.

Finally East Village business owners have a right to understand the nature of a proposed event and to vote whether to allow it on their street.
