APPROVAL OF LEASE AGREEMENT WITH HISTORIC STERNWHEELER, LLC FOR DOCK IN VICINITY OF BIRDLAND MARINA AND OFF-SEASON RENTAL OF SPACE IN BIRDLAND MARINA

WHEREAS, the City owns and operates Birdland Park and Birdland Park Marina; and

WHEREAS, Historic Sternwheeler, LLC, Michael La Valle, Manager, desires to lease the below described portion of parkland which is upstream of the Birdland Park Marina harbor entrance fronting on the north bank of the Des Moines River lying adjacent to the Des Moines River for the purpose of installing a floating dock and mooring such dock to the river bottom as a moorage and maintenance site for an excursion riverboat boat and to lease space within Birdland Marina during the off-season for winter moorage of said boat; and

WHEREAS, the real estate within Birdland Park to be leased for the dock moorage is as follows:

The Westerly 10.0 feet of the North 75. feet of the South 425.0 feet of the West ¾ of the North ½ of Lot 7 (lying West of the road), of Thompson Estate of Section 35, Township 79 North, Range 24 West of the 5th P.M., all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

WHEREAS, a Lease Agreement has been prepared, a copy of which is on file in the City Clerk's Office, which provides for an annual rental payment of \$_____ for an approximately two year term from November 1, 2008 until October 31, 2010; and

WHEREAS, the Park and Recreation Department recommends favorably as to the amount of the proposed rental and as to this use of Birdland Park and Marina; and

WHEREAS, the City Council deems it advisable to approve this proposed lease.
