WHEREAS, the City of Des Moines, Iowa, has been informed by Robert Mickle, President of the Neighborhood Investment Corporation the general partner of Stockbridge, L.P., that a 42-unit family housing development located at 1815 High Street received an allocation of low income housing tax credits for 2007; and

WHEREAS, by Roll Call 06-2240 on November 6, 2006 the City Council supported the low-income housing tax credit application for this project subject to compliance with City ordinances, which includes the Zoning and Site Plan Ordinances, and the building permit process; and

WHEREAS, the project has a gap in its financing because the project did not receive the full amount of tax credits for which it was eligible and construction costs have increased from when the costs were originally projected in November of 2006; and

WHEREAS, the housing development is eligible for City HOME funds and the Council has a policy to preliminarily commitment up to \$250,000 of HOME funds for individual projects subject to a payback of funds at least a 1% interest rate; and

WHEREAS, the final agreement will require Council approval prior to execution of HOME documents.
