BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the contract and bond, in the amount of \$962,451.70, executed by Des Moines Asphalt & Paving Co., James D. Gauger, President, P.O. Box 3365, 5550 NE 22nd Street, Suite 100, Des Moines, IA, 50316 dated July 23, 2007, for the construction of the following improvement:

2007 Expanded Street Resurfacing Program - Contract 4, 06-2007-014

The improvement includes scarification of existing asphalt streets, furnish and place hot mix asphalt, and furnish and place pavement markings, and other incidental items; in accordance with the contract documents, including Plans File Nos. 473-119/135, at the following locations in Des Moines, Iowa:

- Center Street from 15th Street to 19th Street
- 28th Street from I 235 to School Street
- 22nd Street from Day Street to University Avenue
- 21st Street from Dead end south of Atkins Street to University Avenue
- Hickman Road from 9th Street to ML King Jr. Parkway
- Madison Avenue from 6th Avenue to 12th Street
- Oakridge Drive from Crocker Street to 15th Street
- Easton Blvd from Stewart Street to Delaware Avenue
- E 25th St from E University Avenue to Easton Blvd
- E Grand Avenue from E 18th Street to E 20th Court
- SE 5th Street from E McKinley Avenue to E Army Post Road

The attached "Contractor's Anticipated DBE/TSB Utilization" shows the Contractor's efforts to solicit DBE/TSB Participation in accordance with the Disadvantaged Business Enterprise/Targeted Small Business (DBE/TSB) Program.

BE IT FURTHER RESOLVED: That the Mayor be and is hereby authorized and directed to execute said contract on behalf of the City of Des Moines, and the City Clerk, be and is hereby authorized and directed to attest to same.

BE IT FURTHER RESOLVED: That the City Clerk be and is hereby authorized and directed to return the Contractor's bid security.




