SET DATE OF HEARING FOR APPROVING BUILDING LEASE AGREEMENT WITH TMS MANAGEMENT GROUP INC AT THE DES MOINES INTERNATIONAL AIRPORT

WHEREAS, the City of Des Moines owns and operates an airport known as Des Moines International Airport (hereinafter called the "Airport"), located in Des Moines, Polk County, Iowa; and

WHEREAS, Aviation Department Staff and representatives of TMS Management Group Inc. have negotiated the terms and conditions of a proposed new lease agreement (the "Agreement"); and

WHEREAS, TMS Management Group Inc. desires to lease space in the Airport's terminal building; and

WHEREAS, the term of the proposed Agreement is scheduled to terminate on July 31, 2016, which, being greater than three years, requires approval of the Des Moines City Council; and

WHEREAS, the Airport Board has recommended that Council approve the new Agreement;
