WHEREAS, United Airlines Inc. desires to amend its operating agreement and terminal lease at the Airport, lease facilities and premises in the Airport's Terminal Building and execute the Signatory Agreement; and

WHEREAS, the term of the proposed agreement is scheduled to terminate on June 30, 2013, which, being greater than three years, requires approval of the Council; and

WHEREAS, on July 6, 2010, by resolution A10-080, the Airport Board recommended approval of the Scheduled Airline Operating Agreement and Terminal Lease with United Airlines Inc; and

WHEREAS, on July 12, 2010, by Roll Call No. 10-606, City Council directed the City Clerk to publish the notice of said proposal to set a date of hearing for July 26, 2010; and

WHEREAS, pursuant to Sections 364.7 and 362.3 of the Code of Iowa, notice of the hearing on the proposed authorization of the Agreement has been duly published as provided by law; and

WHEREAS, the public meeting and hearing has been duly held at the time and place provided and in accordance with said notice, those interested in the proposal both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council; and

WHEREAS, it is in the best interests of the City to approve the Agreement;
