WHEREAS, Chapter 10 Article I section 10-14 of the Municipal Code of the City of Des Moines provides for a license fee for music permits to be in the amounts set in the Schedule of Fees adopted by the City Council by resolution; and

WHEREAS, an amendment to the Schedule of Fees setting the new music permit fee has been prepared for Council consideration and is recommended for adoption, which amendment is appended hereto and is now on file in the office of the City Clerk;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the amendment to the Schedule of Fees appended hereto is hereby approved and adopted.

AND BE IT FURTHER RESOLVED that the City Clerk is hereby authorized and directed to incorporate said amendment into the Schedule of Fees, and to maintain said Schedule of Fees, as amended, on file in the offices of the City Clerk for public reference, said amendment to become effective at the same time as the new Chapter 10 Article I Section 10-14.
