- Bel Aire Road from Lower Beaver Road to 890' East of Lawnwoods Drive
- Brentwood Drive from River Oaks Drive to Cul-de-sac West
- Burlington Terrance from Chautauqua Parkway to Nash Drive
- Carpenter Avenue from 39th Street to 360' East of 39th Street
- Chautaugua Parkway from Hickman Road to Stephenson Way
- Douglas Avenue from 12th Street to 16th Street
- Gilmore Avenue from 28th Street to 30th Street
- Harwood Drive from 42nd Street to Polk Boulevard
- Harwood Drive from Polk Boulevard to Woodland Avenue
- Lyon Street from E. 25th Street to E. 29th Street
- Sandahl Avenue from North Union Street to E. 8th Street
