RESOLUTION AUTHORIZING THE CITY MANAGER TO WORK IN COOPERATION WITH POLK COUNTY AND NEIGHBORHOOD DEVELOPMENT CORPORATION TO RESEARCH POTENTIAL REDEVELOPMENT OF PROPERTY LOCATED AT 4315 SE 14TH STREET

WHEREAS, by Roll Call Nos. 07-1320 and 07-1321 of July 9, 2007, the City Council received, filed and referred to the City Manager, letters from the Southeast 14th Street Steering Committee and Ward 4 Mobile Home Park Committee which letters addressed objectives and actions for revitalizing the Southeast 14th Street Corridor and outlined strategies for mobile home park redevelopment; and

WHEREAS, following City staff review, the City Manager by letter to the City Council dated December 12, 2007 provided recommendations for southside revitalization including mobile home park redevelopment; and

WHEREAS, the City Manager has forwarded a recommendation for the City to research the development potential of the mobile home park at 4315 SE 14th Street in conjunction with Polk County and Neighborhood Development Corporation.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the attached Council Communication is hereby received and filed and the City Manager is hereby authorized and directed to work in cooperation with Polk County and Neighborhood Development Corporation to research the development potential of property located at 4315 SE 14th Street, including research of all issues relating to the relocation of mobile home park residents.



Re: City of Des Moines Neighborhood Development Corporation Grant Money

The Indianola Hills Neighborhood Association members are interested in redeveloping areas in distress within the south side of Des Moines and see a great opportunity for city grant money to be put to good use.

Our city councilman representative Brian Meyer brought in to the attention of the Coalition of South Side Neighborhoods (CSSNA) of which there are now eleven, that the owner of the mobile home park at 4315 SE 14th Street expressed an interest in selling the park.

There are over a dozen Manufactured Housing locations on the south side of Des Moines and with a few exceptions, most of them are in terrible shape, creating a blight in the areas in which they reside and also, not a good place for families to raise children.

Since the City of Des Moines gives grant money to the Neighborhood Development Corporation to work on redeveloping areas in distress, our association would like to recommend that grant money be used for the following things:

- That the Neighborhood Development Corporation purchase the Mobile Home Park at 4315 SE 14th from the current owner.
- 2. That the Neighborhood Development Corporation would work with the city on Transitional Housing.
- 3. That the Neighborhood Development Corporation would help find a developer/investor.

It has been a goal for CSSNA to work with the city on the mobile home parks, but we have always run into obstacles since the owners didn't want to sell their parks or because they were protected by grandfather type clauses with the city. Since we now have an owner who would like to sell, this should be a great time to implement a mobile home park remediation plan.

Please give consideration to our request as we continue to try and redevelop the blighted areas on the south side.
