## APPROVING PRIVATE CONSTRUCTION CONTRACT BETWEEN ELDER CORPORATION AND DRAKE UNIVERSITY FOR PAVING, SIDEWALK, AND STORM SEWER IMPROVEMENTS IN UNIVERSITY AVENUE AND FOREST AVENUE AT VACATED 28TH STREET, DES MOINES, IA

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the contract documents for a Private Construction Contract between Elder Corporation, Jared R. Elder II, President, 5088 E. University Avenue, Des Moines, IA, 50327 - as Contractor, and Drake University, Victoria Payseur, Vice President for Business & Finance, 2507 University Avenue, Des Moines, IA, 50311 - as Owner, for construction of Paving, Sidewalk, and Storm Sewer Improvements described as construction of pedestrian dropoff lanes on University Avenue and Forest Avenue at vacated 28th Street including curb removal, PCC pavement widening, sidewalk, and storm sewer in accordance with the contract documents including Plan File Numbers 491-110/134, be and the same are hereby approved, subject to receipt on plans, contracts, and performance, payment, and maintenance bonds acceptable to the City Engineer and Legal Department.

BE IT FURTHER RESOLVED: That permission be and is hereby granted to the parties of said contract to construct said Paving, Sidewalk, and Storm Sewer Improvements in accordance with said contract documents and subject to inspection and approval of the Des Moines City Engineer, and also subject to receipt on plans, contracts, and performance, payment, and maintenance bonds acceptable to the City Engineer and Legal Department.


