## RESOLUTION AUTHORIZING SUBMISSION OF AN APPLICATION FOR FINANCIAL ASSISTANCE TO THE STATE OF IOWA DEPARATMENT OF ECONOMIC DEVELOPMENT AND APPROVING PRELIMINARY TERMS OF AN ECONOMIC DEVELOPMENT LOAN OF \$120,000 TO HEALTHWAYS.

WHEREAS, Healthways (Dennis Jackson, VP of Procurement/Facilities, 3841 Green Hills Village Drive, Nashville, TN 37215) is a leading provider of specialized, comprehensive disease management services; and

WHEREAS, Healthways has prepared a State of Iowa Application for Financial Assistance for a Community Economic Betterment Account (CEBA) loan which requires the Mayor's signature prior to submittal to the State; and

WHEREAS, Healthways has applied to the City for a loan in the amount of \$120,000 to assist the business expansion project that will add 100 new jobs to downtown Des Moines; and

WHEREAS, the loan amount will be funded from the Economic Development Enterprise Account; and

WHEREAS, the City desires to accomplish a public purpose by dispensing funds in a project which will involve private investment and the creation of new jobs and income pursuant to Iowa Code Chapters 15A and 403; and

WHEREAS, the public gains and benefits generated from this economic development activity are warranted in comparison to the amount of funds invested.

## NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. Preliminary approval is hereby given for an economic development loan in the amount of \$120,000 to Healthways under the terms and conditions outlined in the attached Council Communication. The City Manager is authorized to negotiate the final terms of the Loan Agreement and prepare all related documents.
- 2. Should the loan documents not be approved and executed within 12 months from this date, this preliminary funding commitment shall be rescinded and the funds shall be available for reallocation.
