WHEREAS, pursuant to Iowa Code sections 364.7 and 362.3, notice of the hearing on the proposed authorization of the Agreement has been duly published as provided by law; and

WHEREAS, the public hearing has been duly held at the time and place provided and in accordance with the notice, those interested in the proposal both for and against, have been given an opportunity to be heard and have presented their views to the City Council; and

WHEREAS, it is in the best interests of the City to approve the agreement;
