



On July 27, 2010, OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, James Gauger, President, 5550 NE 22nd Street, P.O. Box 3365, Des Moines, IA 50316-0365 submitted a proposal for construction of the 2010 Expanded Street Resurfacing Program - Contract 2, Activity ID 06-2010-016, which the City Council has determined to be the lowest responsible, responsive bid for said project in the amount of \$1,686,417.47.
