APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR SANITARY IMPROVEMENTS, 3525 VANDALIA ROAD, BETWEEN HALBROOK EXCAVATING, INC. AND HELENA INDUSTRIES

WHEREAS, on May 5, 2008 under Roll Call No. 08-770, the City Council approved a private construction contract in the amount of \$29,550.00, between Halbrook Excavating, Inc., Larry A. Halbrook, President, 4807 SE Rio Court, Ankeny, IA, 50021 - as Contractor, and Helena Industries, Rob Baldwin, President, 3525 Vandalia Road, Des Moines, IA, 50306 - as Owner, for construction of Sanitary Improvements described as modifications to the sanitary sewer near 3525 Vandalia Road, Des Moines IA including construction of 70 LF of 12" PVC forcemain with 18" steel casing and 70 LF of 15" gravity sewer with 21" steel casing in accordance with the contract documents including Plan File No. 476-024, which is required before the construction of a new railroad spur over the existing sanitary sewer, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Sanitary Improvements in the amount of \$29,550.00, which have been constructed in substantial compliance with the contract documents between Halbrook Excavating, Inc. and Helena Industries, which were approved under Roll Call No. 08-770, dated May 5, 2008, be received and filed; and that completion of said Sanitary Improvements described as modifications to the sanitary sewer near 3525 Vandalia Road, Des Moines IA including construction of 70 LF of 12" PVC forcemain with 18" steel casing and 70 LF of 15" gravity sewer with 21" steel casing in accordance with the contract documents including Plan File No. 476-024, which is required before the construction of a new railroad spur over the existing sanitary sewer, is hereby acknowledged and that said Sanitary Improvements are hereby accepted.




