HONORABLE MAYOR AND MEMBERS OF THE DES MOINES CITY COUNCIL

Re: Item No. 52, Ordinance amendment regarding general penalty for misdemeanors

The Iowa Legislature enacted changes to the Iowa Code which affect the penalty that can be charged for misdemeanor violations of the city code. The change harmonizes the penalty for city misdemeanors with the maximum penalty which can be charged for state misdemeanors. Before this legislation, the maximum fine for violating a city ordinance was \$500.00, which has been the maximum for many years. If the city council adopts the proposed ordinance amendment, the maximum fine would become \$625.00, the current maximum under the Iowa Code.

A Roll Call approving an ordinance amending the Des Moines Municipal Code to coordinate the maximum penalty with the limit imposed by state law appears on your July 27th Agenda. I recommend its adoption.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,374 passed September 27, 2004 and Ordinance No. 14,611 passed December 4, 2006 is hereby amended by amending paragraph (b) of Section 1-15 relating to general penalty for misdemeanors, as follows:

Sec. 1-15. General penalty.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

⁽b) Whenever in this Code or in any city ordinance any act is prohibited and is declared to be a misdemeanor or whenever in this Code or in any city ordinance the doing of any act is required and the failure to do that act is declared to be a misdemeanor, the violation of any such provision shall be punishable by a fine not exceeding \$500.00 or by imprisonment not exceeding 30 days to exceed the maximum amount of dollars or imprisonment not to exceed the maximum number of days as provided in Section 903.1, subsection 1, paragraph a of the Iowa Code.
