NATURAL RESOURCES CONSERVATION SERVICE (NRCS) PROJECT AGREEMENT FOR THE EMERGENCY WATERSHED PROTECTION PROGRAM AND OPERATION AND MAINTENANCE AGREEMENT FOR 1235 DAVIS AVENUE SOIL STABILIZATION (TRELEN J. WILSON AND LINDA L. BENDER, PROPERTY OWNERS)

WHEREAS, on September 22, 2008 by Roll Call No. 08-1662, Council authorized and directed the City Manager to make application with the United States Department of Agriculture (USDA) for assistance under its Emergency Watershed Protection (EWP) Program for certain property owners in the City of Des Moines who experienced issues with land sliding on their property resulting from the flooding and rain conditions of 2008; and

WHEREAS, said application was made and funding pursuant to the USDA's EWP Program is available for construction of slope stabilization on the property located at 1235 Davis Avenue, Des Moines, Iowa owned by Trelen J. Wilson and Linda L. Bender; and

WHEREAS, on February 23, 2008, by Roll Call No. 09-280, Council authorized and directed the Mayor to execute the agreement between the City and Trelen J. Wilson and Linda L. Bender regarding the City's sponsorship to obtain financial assistance through the EWP Program with the USDA Natural Resource Conservation Service for the property; and

WHEREAS, on June 8, 2009, by Roll Call No. 09-1005, Council authorized and directed the Mayor to execute the USDA-NRCS Project Agreement for the EWP Program and Operation and Maintenance Agreement for 1235 Davis Avenue (Trelen J. Wilson and Linda L. Bender, Owners) Soil Stabilization; and

WHEREAS, following Council approval, the USDA-NRCS would not execute or approve the agreement due to a recent change in funding for the EWP Program in Iowa, and instead forwarded a revised Cooperative Project Agreement (Locally Led Contracting) and attachments thereof, and Operation and Maintenance Agreement and Plan, both agreements being on file in the Office of the City Clerk, for 1235 Davis Avenue Project to the City for approval prior to funding the project.
