Lots 111 and 112, Gray's Subdivision of Blocks 50 and 62, Brooks and Company's Addition, and the East 1/2 of the vacated North/South alley lying West of and adjoining said Lots 111 and 112, vacated by Ordinance No. 5544, October 11, 1954, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

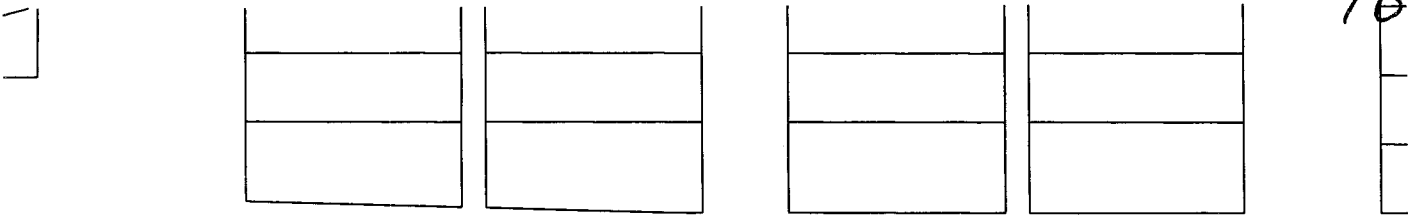

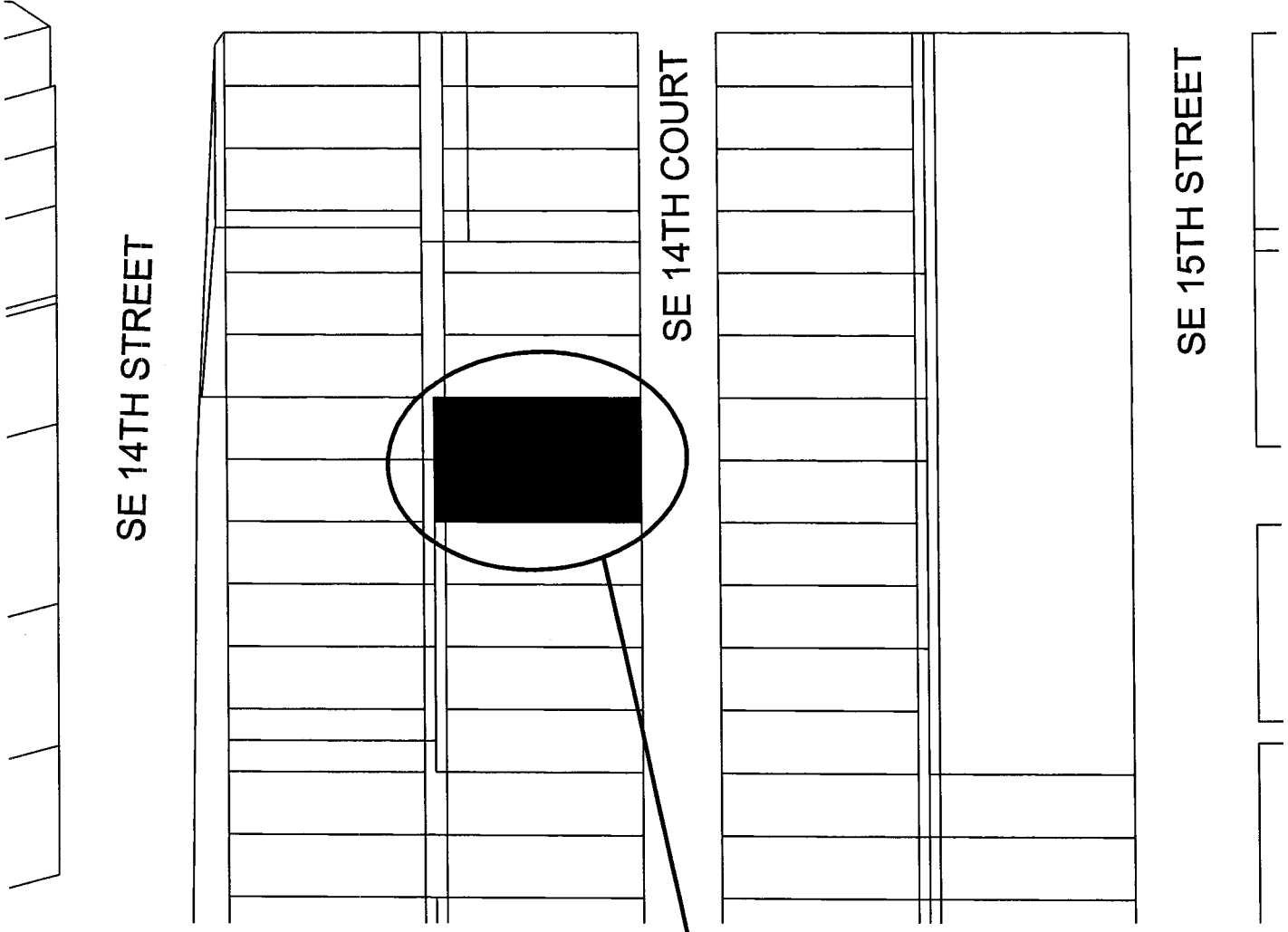

MAURY STREET

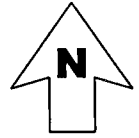


SE 14TH STREET
