## **CERTIFICATION OF COMPLETION:**

On July 14, 2008, under Roll Call No. 08-1273, the City Council awarded Purchase Order No. 21284 to The Underground Company, Ltd., Duane Burkhardt, President, 12245 Dakota Street, Carlisle, Iowa, 50047, for emergency repairs resulting from the June 2008 flooding on the Des Moines and Raccoon Rivers and/or heavy local rains which resulted in surcharge of the sanitary sewers and caused damage to the following public improvements:

800 Block of Boyd Street Sanitary Sewer Repair, Activity ID 14-2008-070: This work includes the repair of the 12" sanitary sewer collapses in the 800 Block of Boyd Street and repair the street. These are additional repairs in this area. Purchase Order Number 21185 was for a sanitary sewer repair of a collapse near E 9<sup>th</sup> and Boyd Street. After this repair was made, the sanitary sewer still did not function and the sewer in the 800 block was televised in an attempt to find the problem. The televising identified additional areas of failure in the 800 Block of Boyd Street that were not as apparent as the initial failure; however, the sewer has failed and needed repair.
