WHEREAS, the low dollar compliant bid was received from Chestnut Signs, 971 NE Broadway Avenue, Des Moines, IA 50313, at a total cost of \$72,704.32; and

WHEREAS, funding is available from PKS990000/PKS137, Capital Projects/Neighborhood Park Improvements; and

WHEREAS, the Procurement Administrator and the Park and Recreation Department recommend approval of the low dollar compliant bid;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the low dollar compliant bid for parks signage as submitted by Chestnut Signs at a total cost of \$72,704.32.

BE IT FURTHER RESOLVED, that one additional primary entrance sign for the McCollum Waveland Tennis Complex be awarded to Chestnut Signs at the same bid price of \$7511.52, less a \$2500.00 donation, for a total award value of \$77,715.84.
