

Dear Frank and Christine:

Reference is made to the enclosed letter from the Mayor of Norwalk. As you can see, the Norwalk City Council passed a resolution supporting a name change of "County Line Road" from Highway 28 to Fleur Drive to "Echo Valley Drive". The road is approx 1½ miles long and we own all of the land on the south side of the street. The north side of the street is largely comprised of land that is unusable because of the effect of Highway 5. Approximately half of this frontage area is in the City of Des Moines and the balance is in Norwalk. The land in Des Moines is very high profile and I believe a name change from County Line Road only adds to the image of the area. And the truth is in this area the relevance of a name change has very little impact on anyone.

We have big plans for the area and Des Moines will certainly be a beneficiary. If you would like to get together and discuss this in more detail I would be happy to meet with you; or perhaps a meeting with the City of Norwalk and Des Moines is in order to discuss the matter further.




MASTER LAND USE AND GOLF COURSE SITE PLAN
