RESOLUTION APPROVING AGREEMENT WITH SHERRY SMITH TO PRESERVE THE CITY'S RIGHT TO TAKE A TAX DEED TO THE VACANT LOT AT 1622 FOREST AVENUE INTENDED FOR REDEVELOPMENT FOR HOUSING

WHEREAS, Sherry Smith, sometimes known as Sherry Wiggins, is the titleholder of the vacant lot at 1622 Forest Avenue (the "Property"); and,

WHEREAS, on March 6, 2006, by Roll Call No. 06-442, the City Council approved the purchase of the 2003 Tax Sale Certificate for the Property from OHP1, L.C., a subsidiary of Oak Helm Partners represented by John Howes, to permit the Property to be redeveloped for housing; and,

WHEREAS, the City has given notice of expiration of the right of redemption from the 2003 tax sale pursuant to Iowa Code §447.9; and,

WHEREAS, on August 7, 2006, by Roll Call No. 06-1585, the City Council approved the assignment of the 2003 Tax Sale Certificate for the Property to Community Housing Development Corporation for construction of housing; and,

WHEREAS, Ms. Smith has declared her intent to redeem the Property from the 2003 tax sale unless she is compensated for her interest in the property as provided below; and,

WHEREAS, the City desires that Ms. Smith not redeem the Property from the 2003 tax sale, to permit Community Housing Development Corporation to obtain a tax deed under the 2003 Tax Sale Certificate and redevelop the Property for residential use; and,

WHEREAS, the City Manager has negotiated an Agreement with Ms. Smith whereby she has agreed to forego her right to redeem the Property in exchange for a payment of \$4,000.00; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The Mayor is hereby authorized and directed to sign the proposed Agreement with Sherry Smith on behalf of the City of Des Moines, Iowa.


