WHEREAS, the Iowa Department of Commerce, Alcohol Beverage Division, will reimburse the City of Des Moines for costs associated with the program; and,


WHEREAS, the Iowa Department of Commerce, Alcohol Beverage Division, has developed a reimbursement agreement to implement this; and,
