BE IT FURTHER RESOLVED, that the above described Agreement Between the City of Des Moines and Prairie Landscapes of Iowa, LLC, a copy of which is on file with the City Clerk's Office, is hereby approved, and the City Manager is authorized and directed to sign said agreement on behalf of the City and the City Clerk is directed to attest to his signature.
