RESOLUTION APPROVING DOCUMENTS RELATED TO NEIGHBORHOOD COMMERCIAL REVITALIZATION PROGRAM GRANTS AND AN ECONOMIC DEVELOPMENT BRIDGE LOAN TO THE PARKS AREA FOUNDATION FOR RENOVATION OF PROPERTY AT 3600 6<sup>TH</sup> AVENUE

WHEREAS, on July 27, 2009 by Roll Call No. 09-1336, the City council gave preliminary approval for a Neighborhood Commercial Revitalization Program (NCR) \$15,000 façade grant, a \$5,000 pre-development grant and a \$100,000 economic development bridge loan to assist the renovation to historical standards of the Aqualand Building at 3600 6<sup>th</sup> Avenue in Des Moines owned by the Parks Area Foundation (Developer); and

WHEREAS, Developer proposes to improve the property by completing historical façade, structural and internal renovations. The first floor of the building will be leased as retail space and the second floor will be remodeled for residential uses; and

WHEREAS, the proposed project will assist in continued efforts to revitalize the Highland Park Historic Business District at Euclid in Des Moines by enhancing the value of commercial and residential property and by providing additional services; and

WHEREAS, the State of Iowa Historical Preservation Office has approved the project design in conjunction with Developer's application for State of Iowa Historical Tax Credits to be issued upon completion of the renovations; and

WHEREAS, the \$100,000 economic development bridge loan will assist in the up-front renovation costs and will be repaid through issuance and sale of State of Iowa Historical Tax Credits on the completed project. The NCR façade grant is a 1:1 matching grant not to exceed \$15,000 for building façade improvements. The NCR pre-development grant is a 1:1 matching grant not to exceed \$5,000 for architectural and engineering fees, feasibility studies, environmental assessments and other soft costs.

WHEREAS, Developer has executed the attached economic development loan agreement, promissory note and mortgage and the City Council finds the form of the attached documents to be acceptable.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. The documents are hereby approved and the Mayor is authorized and directed to sign the attached documents and the City Clerk is authorized to attest to the Mayor's signature and to obtain proper acknowledgement.
