APPROVAL OF SUPPORTIVE HOUSING PROGRAM (SHP) RENEWAL GRANT AGREEMENT WITH THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, in response to a Super NOFA published in the Federal Register on March 13, 2007, to supplement funding for local homeless programs, the City's Housing Services Department prepared an application for \$2,655,424 in Continuum of Care Program funds; and

WHEREAS, the application was developed from the City's Continuum of Care strategy, whereby Continuum of Care Program funds would provide needed services to homeless persons in Des Moines and address high priority service gaps within the parameters of Continuum of Care-eligible activities; and

WHEREAS, on June 4, 2007, by Roll Call No. 07-1076, the City Council approved the above-referenced Continuum of Care application and authorized and directed the City Manager to submit the application to the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, HUD has now forwarded a 2007 SHP Renewal Grant Agreement for a total of \$75,372, on file with the City Clerk as Exhibit A, and by this reference made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above-referenced Renewal Grant Agreement by and between HUD and the City of Des Moines, whereby the City will receive a grant award of \$75,372 of 2007 SHP funding for continuation of the West Des Moines Transitional Housing Program (\$75,372) is hereby approved.

BE IT FURTHER RESOLVED that the Mayor Pro Tem is hereby authorized and directed to execute the above-referenced Renewal Grant Agreement and the City Clerk to attest to her signature.

BE IT FURTHER RESOLVED that regarding contract amendment procedures all proposed amendments to work programs and written agreements with subrecipient entities that are not in accordance with City Council approval of the aforementioned SHP project or that constitute a substantive change in the location, service level, time period, budget, or project purpose shall be submitted to the City Council for consideration and approval prior to execution by the City Manager.
