WHEREAS, the Commercial Service Vertical Infrastructure Fund provides for one-half of the appropriated funds to be allocated equally between each of the Commercial Service Airports and the remaining forty percent and ten percent of the funds are divided based on enplanements and cargo activity, respectively. Enplanement data was based on the most current data available from the Federal Aviation Administration (FAA), which is calendar year 2007.

WHEREAS, the distribution formula will provide the Des Moines International Airport with \$567,255.00 for the current Fiscal Year, July 1, 2008 to June 30, 2009; and

WHEREAS, on, March 4, 2008, by Resolution No. A08-046, the Airport Board approved the application to the Iowa Department of Transportation for funding from the Commercial Service Vertical Infrastructure Program to construct a new Airfield Vehicle Storage Building, Airport Terminal Modifications for EDS Deployment, and a new Sand/Chemical Storage Building.; and

WHEREAS, on September 3, 2008, by Resolution No. A08-183, the Airport Board recommended to City Council the approval of the grant agreement between the City and IDOT providing funding for the projects;
