WHEREAS, the subdivision plat entitled **Hillsboro Plat 3**, located east of Indianola Avenue and south of East Pine Avenue, developed by Jerry's Homes, Jerry Grubb, Principal, was approved by the City Council on October 6, 2003, by Roll Call No. 03-2290; and,

WHEREAS, by such Roll Call No. 03-2290, the City Council also approved and accepted Sidewalk Bond No. IAC 34838 from Merchants Bonding Company in the amount of \$23,507 as security for the estimated cost of completing the required sidewalk improvements for such plat; and,

WHEREAS, the City Engineer and Community Development Director have certified that the required improvements have been satisfactorily completed and recommend that the security in the amount of \$23,507 for such improvements be released and returned to the developer; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. That Sidewalk Bond No. IAC 34838 in the amount of \$23,507 from Merchants Bonding Company as Surety, and Jerry's Homes, Inc., as principal, is hereby released and shall be returned to the principal now that the improvements have been completed.
