In 2001 I contacted Jack Bishop, Chairperson, for the county to restore their Polk County War Memorial. Instead he threw me a curve saying half of the responsibility lies with the City since it is on City ground. In April of 2007 I contacted Tom Hockensmith, Chairperson and his thinking was and is that it is, indeed, a Polk County monument. Both Christine Hensley, Councilperson and Tom Vlassis, Councilperson, will recall my coming before the Council requesting funds.

The Polk County Board of Supervisors have now gone the 2nd mile. But, there is still a major problem with the monument: excess to the monument by the public.

The two grand stairways lead to University Ave. where there are "no parking" signs located all alone the street on both sides. The next street over, a block away, is a <u>private</u> street for one purpose: for the employees of IOwa Lutheran to park, and it is filled 24-hours a day. Fifth Street is no more as taken over as a drive for the Wallace-Longfellow school. The next street over is 5 blocks away: Pennsylvanis.

Many of the citizens are very old or handicaped. The parking in the hospital lot is not dependable and discouraging, and no place for a children's school bus.

You have 15 acres in the veterans John Buke Park. Every park in the City has some parking. I suggest that there be a 50'x50' parking lot located on the eastern edge of the park with a sign "30 minute parking for viewing of the monument strickly enflorced".

Once you provide parking for one space for a school bus, one space for the hanicaped and two places for other cars, I will contact the Dept. head of Social Studies at the Des Moines Public Schools and provide what the monument is all about to be given to Social Studies teachers. All field trips would go through the Dept. head so only one bus would be there at a time. It is important that the young children appreciate this hard won monument as they will inherit it.

You will need two car parking places for a 25' driveway. If Iowa Lutheran is uncooperative <u>remind them a good number of years ago</u> the City gave them 25' all along the east edge of the park to them. In exchage for the Iowa Lutheran has maintained the Park, grass cutting, clean-up, etc.

Mayor Cownie and Council members, I will be at your meeting on Sep- tember 10. I would think such legislation should be a prioity.
