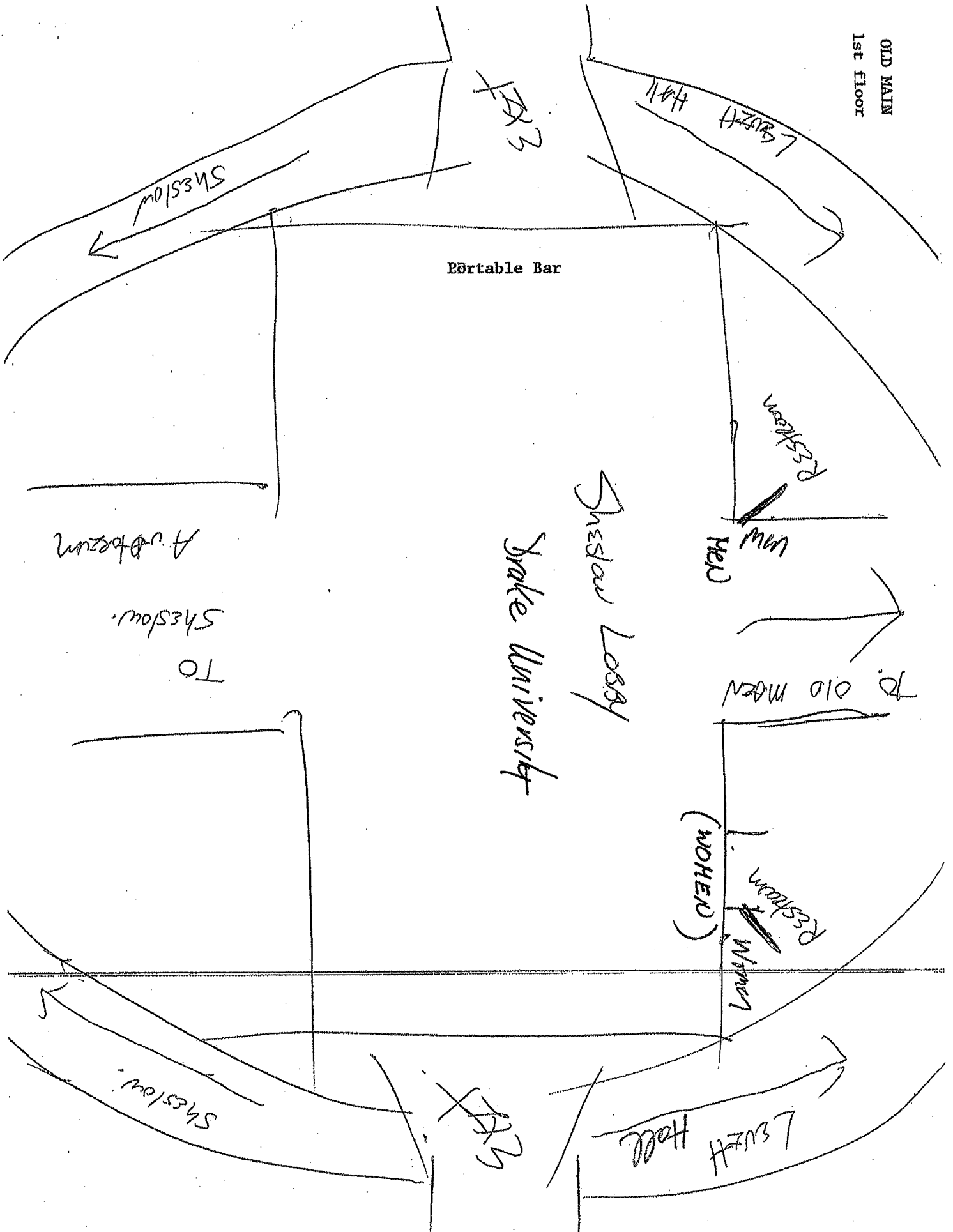

1st Floor

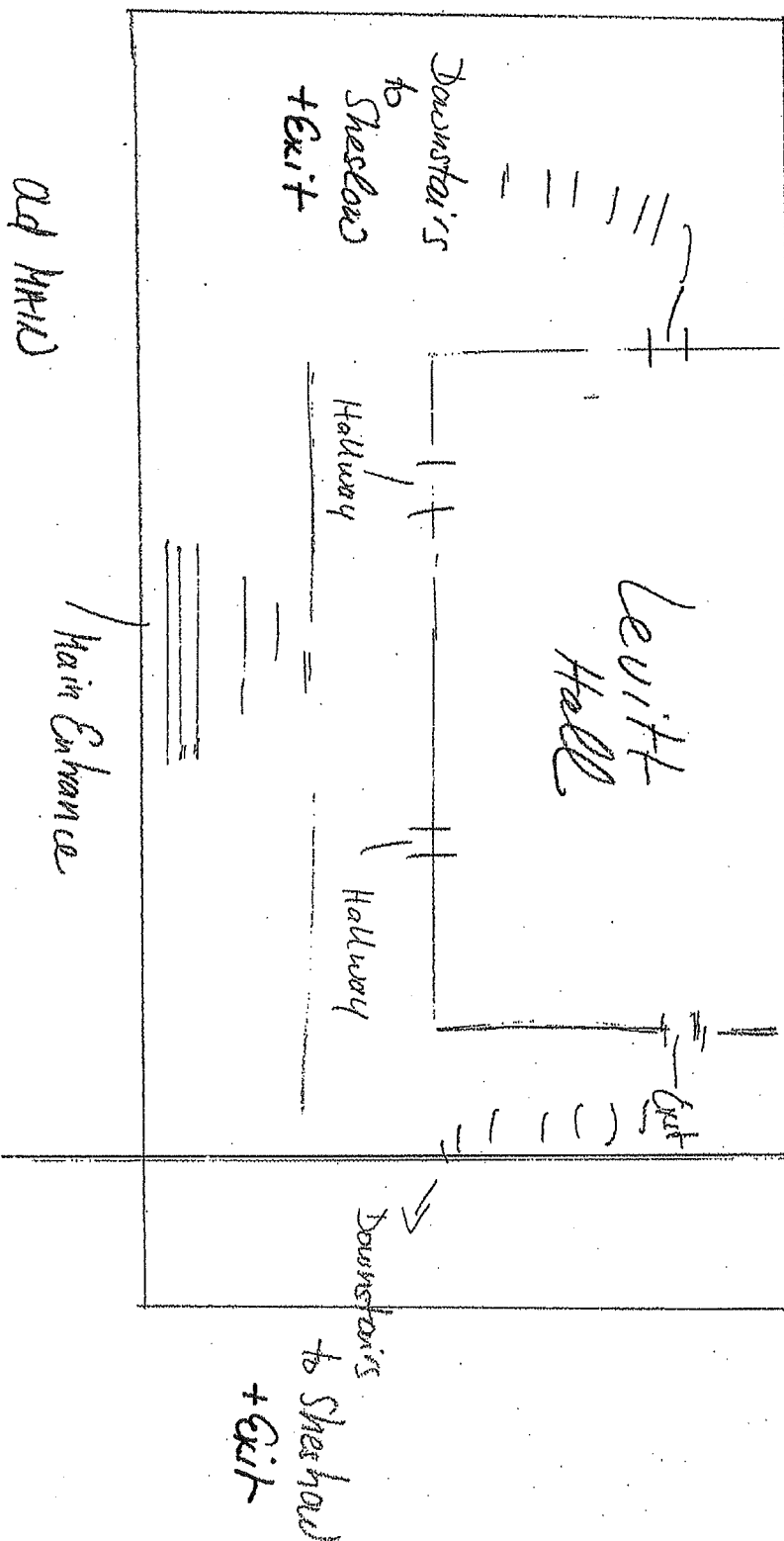

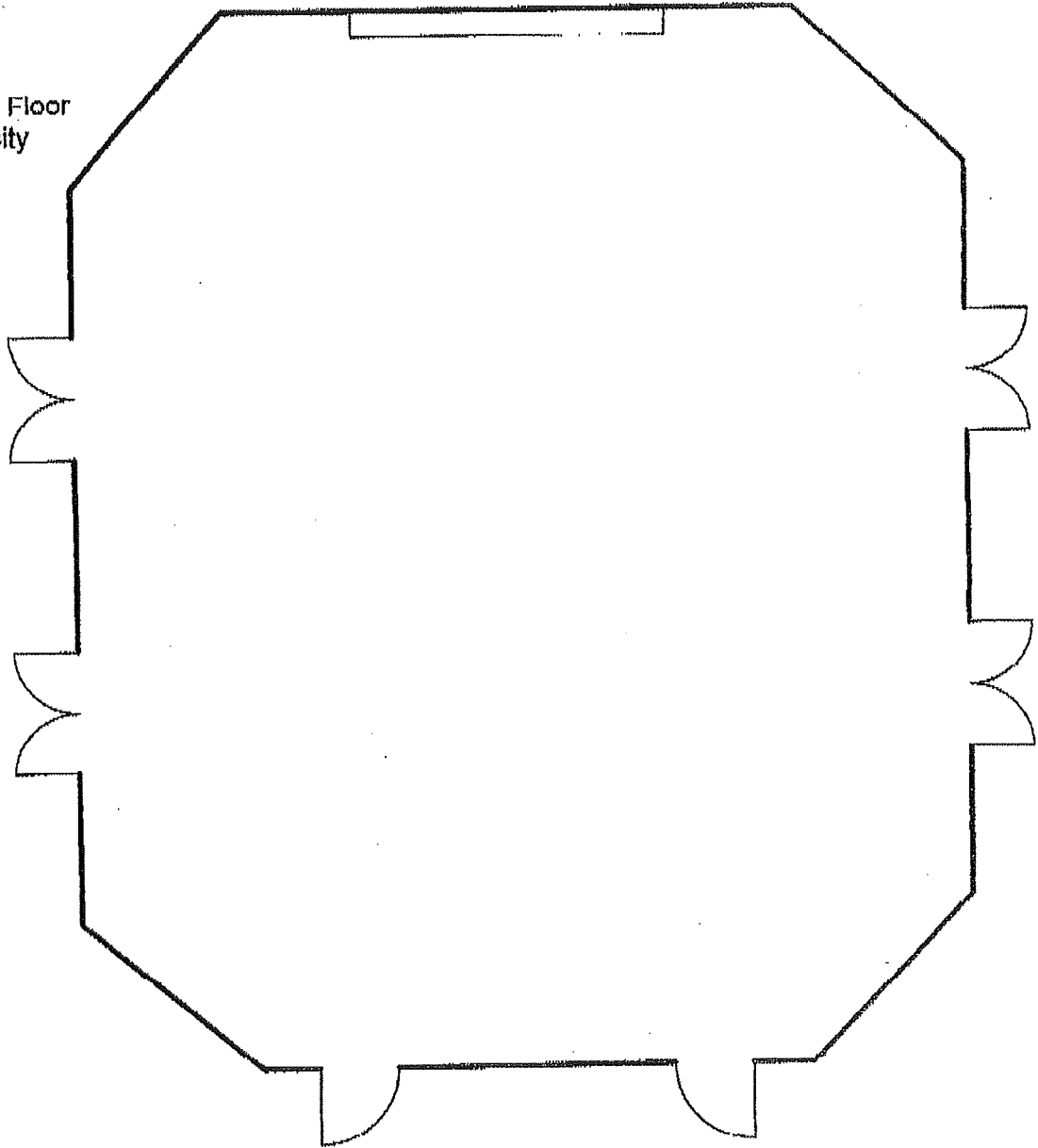


