Setting Date of Public Hearing on the Proposed Third Amendment to the SE Agribusiness Urban Renewal Plan

WHEREAS, on January 26, 1998, by Roll Call No. 98-275, the City Council adopted the Urban Renewal Plan for the SE AgriBusiness Urban Renewal Project, and such Plan has been amended two times (the urban renewal plan as amended is hereinafter referred to as the "Plan"); and,

WHEREAS, the SE AgriBusiness Urban Renewal Project Area encompasses an irregularly shaped area generally located between S.E. 14th Street and the eastern City boundary, and between Dean Avenue and the Des Moines River; and,

WHEREAS, the purpose of the proposed Third Amendment to the Plan, attached hereto as Exhibit "A", is to update and restate the Plan language and maps to clarify Plan objectives on the location and construction of public improvements, include the acquisition, construction and equipping of a Des Moines Fire Department logistics and training facility as a specified public improvement Project proposal, designate an acquisition parcel for the proposed public safety training facility and provide for additional uses and specified public improvements to be financed with tax increment revenues; and,

WHEREAS, the City Plan and Zoning Commission and the Urban Design Review Board will have an opportunity to review the proposed Third Amendment at their regularly scheduled meetings and should be prepared to submit their report and recommendation to the City Council before the date proposed for public hearing; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. A public hearing shall be held before the City Council to consider the proposed Third Amendment at 5:00 p.m. on October 27, 2008, in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa.
- 2. The City Clerk is authorized and directed to publish notice of said public hearing in the form attached hereto as Exhibit "B". Said notice shall be published in the Des Moines Register on October 13, 2008.
