HOLD HEARING FOR CONVEYANCE OF A PORTION OF THE VACATED NORTH/SOUTH ALLEY RIGHT-OF-WAY BETWEEN EAST 29TH STREET AND EAST 29TH COURT, SOUTH OF DEAN AVENUE, TO RONALD A. CONN FOR \$50

WHEREAS, on November 19, 1984, by Roll Call No. 84-5326, the City Council approved Ordinance No. 10,546 vacating the North/South alley right-of-way between East 29th Street and East 29th Court, South of Dean Avenue; and

WHEREAS, Ronald A. Conn is the owner of property abutting such vacated right-of-way and has offered to the City of Des Moines the purchase price listed below for the purchase of such City-owned property, more specifically described below; and

WHEREAS, on September 10, 2007, by Roll Call No. 07- 1715, it was duly resolved by the City Council that the proposed conveyance of a portion of the vacated North/South alley right-of-way between East 29th Street and East 29th Court, South of Dean Avenue, be set down for hearing on September 24, 2007, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to convey this public real property was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in this proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. Upon due consideration of the facts and statements of interested persons, the objections to the proposed conveyance of this property, as described below, are hereby overruled and the hearing is closed.
2. There is no public need for the property described below and the public would not be inconvenienced by reason of the conveyance of this property to the grantee and for the consideration more specifically described as follows:

To: Ronald A. Conn for \$50

The West ½ of the vacated North/South alley right-of-way lying East of and adjoining Lot 28, Block H, Hartley’s Addition to Grant Park, an Official Plat, and the East ½ of the vacated North/South alley right-of-way lying West of and adjoining Lot 25 of said Block H, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

3. That the sale and conveyance of such right-of-way to the buyer and for the consideration described above, together with payment by such grantee of the estimated publication and recording costs for this transaction, be and is hereby approved.
4. The Mayor is authorized and directed to sign the Offer to Purchase and Quit Claim Deed for the conveyance as identified above, and the City Clerk is authorized and directed to attest to the Mayor's signature.
5. The City Clerk is authorized and directed to forward the original of the Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Real Estate Division of the Engineering Department for the purpose of causing said documents to be recorded.
6. The Real Estate Division Manager is authorized and directed to forward the original of the Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Deed and copies of the other documents to the grantee.
8. The proceeds from the sale of this property will be deposited into the following account: 2007-08 Operating Budget, Page 259, Property Maintenance, SP767.

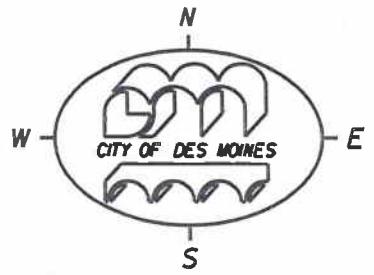
