AUTHORIZATION TO SUBMIT COMMUNITY ATTRACTION AND TOURISM GRANT APPLICATION AND TO REAPPROPRIATE \$50,000 OF FY 2006-07 PARK AND RECREATION DEPARTMENT CIP BUDGET FOR EVELYN K. DAVIS PARK IMPROVEMENTS

WHEREAS, the City of Des Moines Park and Recreation Department is charged with providing clean, safe, and beautiful parks and recreation facilities; and

WHEREAS, in 1993, following a neighborhood based design process, improvements and complete renovation were made at the Evelyn K. Davis Park; and

WHEREAS, the Park and Recreation Department, Police Department and various private donors desire to provide for redevelopment of portions of the park, including such things as additional landscaping, elimination of some and addition of other athletic facilities, and additional community and family event space and facilities; and

WHEREAS, such park redevelopment plan will be developed in accordance with a neighborhood based design process; and

WHEREAS, private contributions and grant funds have been raised for the construction of such park improvements; and

WHEREAS, the Park and Recreation Department desires to submit a Cultural Attraction and Tourism (CAT) Grant in the amount of \$150,000 from Vision Iowa to assist in the development of this project; and

WHEREAS, such CAT grant requires that. The City contribute funding to the project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City Manager is hereby authorized and directed to apply on behalf of the City for a \$150,000 Cultural Attraction and Tourism (CAT) Grant in the amount of \$150,000 from Vision Iowa for the purpose of constructing the above described improvements to Evelyn K. Davis Park.
