WHEREAS, on December 2, 2003, by Resolution No. A03-285, the Des Moines International Airport Board approved and authorized the design of a public improvement project to construct Runway 13R/31L and authorized the City Manager to proceed with the acquisition of properties needed for the project; and

WHEREAS, on January 6, 2004, by Resolution No. A04-16, the Airport Board approved the Voluntary Acquisition Program on a hardship basis for the properties needed for the Runway 13R/31L Project; and

WHEREAS, on June 1, 2004, by Resolution No. A04-103, the Airport Board approved an Acquisition Program to purchase on a voluntary basis the properties needed for the Runway 13R/31L Project; and

WHEREAS, on March 1, 2005, by Resolution No. A05-42, the Airport Board recommended that the City Council authorize the acquisition of the remaining properties needed for the future Runway 13R/31L by gift, negotiation, or eminent domain; and

WHEREAS, on March 7, 2005, by Roll Call No. 05-541, the City Council approved the acquisition of the remaining properties by gift, negotiation, or eminent domain for the Airport Runway 13R/31L Project; and

WHEREAS, on October 7, 2008, by Resolution No. A08-197, the Airport Board established the fair market value and authorized acquisition of the following described property:

Titleholder: General Manufacturing Company and The Wittern Partnership

Fair Market Value: \$1,830,000 plus closing costs

Property Location: 5725 SW 56th Street and 5041 Army Post Road

Interest to Acquire: Fee Simple

WHEREAS, the City's Real Estate Division made good faith efforts but was unable to negotiate a purchase of the above described property; and

WHEREAS, condemnation proceedings were subsequently instituted for the aforementioned property interests; and

WHEREAS, the Polk County Compensation Commission convened on September 14, 2009, in Des Moines, Iowa; and


WHEREAS, the Sheriff has submitted his certification of costs and report of the award of the commission; and
