I finally spike with Troy Jerman of the Office of Traffic and Safety. Troy is standing in for Tim Crouch, my first contact with the Department of Safety. Mr. Crouch is in Afghanistan on military leave from the D.O.T.

Dear Chairperson Connolly,

I am writing to ask you assistance with a matter of considerable importance to an organization to which I belong.

The Sons of Union Veterans of the Civil War (the legal representatives of and heirs to the Grand Army of the Republic) has undertaken a state-wide project to have twelve bridges along the route of U.S. Highway 6 (the old G.A.R. Highway) named for General Officers from Iowa who served the cause of Union and Freedom in the War of the Rebellion, 1861-1865. In Polk County, the Bridge that we have chosen is the Euclid Avenue Bridge over the Des Moines River. It is our intention that this bridge shall be named after Brigadier General Marcellus Crocker, who was an attorney in Des Moines before the war and who lies buried in Woodland Cemetery (see attached bio of BG Crocker).

Once this project is completed (we have only two bridges left to have resolutions of approval and support granted by the city and county governments, Polk County being one of these) Iowa will be the first state in the nation to have completed this project. The signage for each bridge will be paid for by our organization and shall be of no expense to the taxpayers, and will be placed by the Iowa Department of Transportation.

I am asking that you pass a formal resolution, as required by the Iowa Department of Transportation, before they will complete the project. We cannot proceed until we have all of the necessary city and county resolutions in hand, and are anxious to complete this project in light of the rapidly approaching Sesquicentennial of the Civil war in 2011.

Please advise me of what further measures I might need to take to insure that this happens in a timely manner.

Dear Mayor and City Council Members:

At the July 27, 2009 Council meeting, by Roll Call No. 09-1347, Council received, filed, and referred to the City Manager a request from the Sons of Union Veterans of the Civil War to name the Euclid Avenue Bridge over the Des Moines River in honor of Brigadier General Marcellus Crocker.

Although this bridge is confined in the City of Des Moines and Polk County, it is a State of Iowa bridge and is owned and maintained by the Iowa Department of Transportation (IDOT). Because this bridge is owned by the State of Iowa, it does not fall under the City Council's naming policy which was recently adopted. For this bridge to be named in honor of Brigadier General Marcellus Crocker, IDOT is requiring the City of Des Moines and Polk County to pass a formal resolution to name this bridge.

It is staff's recommendation to concur with the naming request and pass a formal resolution for the naming as outlined in the attached roll call. Please feel free to contact me if you have any questions or concerns.
