Part III. Agenda

Rule 16. Citizen Agenda Requests. Any citizen may request the right to have an item placed on the Agenda (including a request to speak) by filing such request in writing with the City Clerk prior to noon on the Wednesday preceding the Council meeting.

Part V. Citizen Participation

Rule 27. Citizen's Right to Address Council. Persons other than Council Members shall be permitted to address the Council only upon specific Agenda Items.

NOTICE OF ADDRESS ASSIGNMENT

The City of Des Moines through the Community Development Department maintains a street naming and numbering system. It is imperative that we keep an accurate and logical system of property numbering. Correct addressing assists fire and police in responding to emergency situations as well as being used by private businesses in delivery of services.

Structures on the property are required to be correctly identified. If this lot has a structure, and the number has been changed, you must place the new number on the main structure. The digits comprising the numbers placed on the building shall be not less than 2 1/4 inches in height and shall be painted on wood, glass or metal or shall be cut from metal and so colored as to be easily read. Commercial, multi-family and institutional structures should use larger digits as necessary to be visible from the street.

We understand that this change may be an inconvenience and we thank you for your cooperation.. To assist in the change we will forward a copy of this notice to public organizations and utility companies listed below. Notification to any private or business contacts will be your responsibility. Pre-printed change of address forms are provided by post office to assist in notification of the address change. If you have any questions or concerns please feel free to contact me at 283-4516.
