SET PUBLIC HEARING FOR THE PROPOSED FOURTH (2008) YEAR ACTION PLAN OF THE
2005-2009 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)
CONSOLIDATED PLAN

WHEREAS, at their meeting on April 4, 2007, the Neighborhood Revitalization Board (NRB) approved the PY 2008 and 2009 Notices of Funding Availability (NOFAs) for the Fourth (2008) and Fifth (2009) Year Action Plans of the 2005-2009 HUD Consolidated Plan; and

WHEREAS, on May 21, 2007, by Roll Call No. 07-980, the City Council approved the recommendations of the NRB regarding the PY 2008 and 2009 NOFAs for the Fourth (2008) and Fifth (2009) Year Action Plans of the 2005-2009 HUD Consolidated Plan and directed and authorized the Community Development Department to distribute NOFAs to potential operating agencies and City Departments for programs and projects which address the goals and objectives of the Fourth (2008) and Fifth (2009) Year Action Plans of the 2005-2009 HUD Consolidated Plan; and

WHEREAS, it is necessary to obtain the views of citizens regarding community development and housing needs and to provide a forum for citizen comment on the City's proposed Fourth (2008) Year Action Plan of the 2005-2009 HUD Consolidated Plan, a public hearing will be held on November 19, 2007; and

WHEREAS, because this Council seeks to provide an opportunity for citizens to comment on the City's proposed Fourth (2008) Year Action Plan of the 2005-2009 HUD Consolidated Plan, copies of the Plan will be available for review at the Office of the City Clerk, Department of Housing Services Administrative Office, the Logan, Brooks and Forest Avenue Neighborhood Site Offices, and all public libraries until November 19, 2007.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that a public hearing to obtain the views of citizens regarding community development and housing needs in Des Moines and the City's proposed Fourth (2008) Year Action Plan of the 2005-2009 HUD Consolidated Plan to be held on November 19, 2007 at 5:00 p.m. in the Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, is hereby approved.


