AGENDA HEADING:

First reading of an ordinance to amend the Municipal Code of the City of Des Moines to authorize the Park and Recreation Director to issue hunting permits to licensed bow hunters for hunting antlerless deer within the public or private areas in the City designated as the "Des Moines Special Deer Management Zones."

SYNOPSIS:

Recommend approval of an ordinance amendment authorizing the Park and Recreation Director to issue hunting permits to licensed bow hunters for hunting antlerless deer. Bow hunting would only be permitted within the public or private areas of the City designated as the "Des Moines Special Deer Management Zones."

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

Controlled bow hunting of deer within the City limits of Des Moines is held annually in the Fall in response to continued growth in the urban deer population that has resulted in damage to natural vegetation, increased deer/vehicle collisions and damage to private landscaping. The current ordinance does not require bow hunters to obtain a "special use permit" from the Park and Recreation Department when hunting on private property within the boundaries of the City of Des Moines. Registration of all bow hunters with the Park and Recreation Department ensures that hunting rules are disclosed to all hunters regardless of whether they hunt on public or private property within the City. It also assists in documenting the deer harvest and helps to disseminate awareness of hunting rules to participating property owners and the general public.

- Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,999 passed September 24, 2001, and Ordinance No. 14,131 passed August 5, 2002, and Ordinance No. 14,524 passed December 19, 2005, and Ordinance No. 14,587 passed September 25, 2006 is hereby amended by adding a new paragraph (4) to Section 70-84(b) relating to hunting permits, as follows:

Sec. 70-84. Hunting.

(b) Licensed bow hunters meeting the requirements established by the state department of natural resources (DNR) may hunt antlerless deer within the areas designated as the "Des Moines Special Deer Management Zones" on public or private property, under all the following conditions:

(4) Hunters must have a permit issued by the director of the park and recreation department and comply with the terms and conditions of such permit.

(4<u>5</u>) Upon application of the property owner, the director of the park and recreation department may issue a permit which waives the 100 feet residency requirement

as provided in subsection (b)(3) of this section and provide for a lesser distance. Such waiver permit may be issued only after an on-site inspection by the park and recreation department and a determination by the director that the hunt may be safely performed. Such waiver permit may include special hunt restrictions to ensure the safety of the hunt and must adhere to the distance requirements provided in subsection (b)(3) of this section from adjoining properties;

- (5<u>6</u>) Hunters must take all shots from an elevated stand and shoot no further than 25 yards;
- (67) Hunters must comply with all rules of the state department of natural resources for hunting in such zone; and
- $(\underline{78})$ Hunters must take all deer meat to be processed or given to charity.

Sec. 2. This ordinance shall be in full force and effect

from and after its passage and publication as provided by law.
