HOLD HEARING ON VACATION AND CONVEYANCE OF A PORTION OF GRANDVIEW AVENUE AND PORTIONS OF THE ALLEYS IN THE GRAND VIEW COLLEGE CAMPUS TO GRAND VIEW COLLEGE IN CONJUNCTION WITH THE EAST 14TH STREET WIDENING PROJECT FOR \$68,585

WHEREAS, the City of Des Moines is acquiring property interests from Grand View College in conjunction with the East 14th Street Widening – Arthur Avenue to East Tiffin Avenue Project; and

WHEREAS, the grantee identified below is the owner of property abutting such right-of-way and has offered to the City of Des Moines the purchase price identified below for the vacation and purchase of such right-of-way described below; and

WHEREAS, on January 8, 2007, by Roll Call No. 07-035, the City Council adopted a recommendation from the City Plan and Zoning Commission that Grandview Avenue between East 13th Street and East 14th Street; the East/West and North/South alley between Grandview Avenue and Morton Avenue east of East 13th Street; a segment of the East/West alley between Morton Avenue and East Sheridan Avenue from East 14th Street to a point approximately 84 feet to the west; and all of the East/West alley between Grandview Avenue and Boyd Street from East 13th Street to East 14th Street, hereinafter more fully described, be vacated and sold; and

WHEREAS, on September 24, 2007, by Roll Call No. 07-1837, it was duly resolved by the City Council that the proposed vacation and conveyance of such right-of-way be set down for hearing on October 8, 2007, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to vacate and convey this public right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in this proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:
