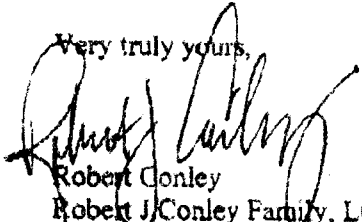
RE: REQUEST FOR WAIVER OF THIRD COUNCIL READING
